The Promoter is Iglu Pty Limited ABN 36 146 695 436, trading as Iglu Student Accommodation.
Referral Friend means the person specified as "Referral Friend's Name" in the Form;
Residential Agreement means a residential agreement in respect of a room and, if applicable, any common facilities at the chosen Iglu property.
