Note 2 Chapter 2 of the *Criminal Code* applies to all offences against the *Statutory Declarations Act* 1959 — see section 5A of the *Statutory Declarations Act* 1959.

A statutory declaration under the Statutory Declarations Act 1959 may be made before-

Bailiff

Bank officer with 5 or more continuous years of service
